## **GENERAL CONDITIONS OF REGISTRATION at prana Inspire retreats**

### **Article 1: Registration and payment**

Registrations are taken into account upon receipt of the signed registration form and full or partial payment by check payable to Avec Inspire.

### **Article 2: Certificate**

Each retreat followed gives the right to a certificate issued on request.

### **Article 3: Cancellation**

Prana Inspire reserves the right to cancel a group if the number of participants is insufficient for its organization or functioning or if unforeseen circumstances require it. In the event of cancellation, the registration fee will be fully refunded within days of notification of the cancellation.

### **Article 4: Withdrawal, interruption**

In the event of cancellation by the intern more than 30 days before the start of the internship, the amount paid will be fully refunded less 15 euros for administrative fees. In the event of cancellation between 15 and 30 days before the start of the course: 50% of the amount paid will be retained. In the event of cancellation less than 15 days before the start of the seminar or for any course started, the total cost paid will be due.

Any internship started and interrupted by the intern will not give rise to any reimbursement (internship and accommodation).

The facilitator can decide to interrupt a participant in his internship and his early return home, for inappropriate behavior within the group or endangering his own physical and or psychological health. The trainee will then be reimbursed for the training days not yet completed on the day of his departure.

### **Article 5: delay and early retirement**

Whatever the reason for any possible delay of a participant in the course and or his departure on his own initiative before the end, the latter may not request any reimbursement or deduction from Prana Inspire which cannot be held responsible.

### **Article 6: Intellectual property**

Audio and video recordings of content discovered during the retreat are not permitted.

Prana Inspire and the facilitator own the workshop content and educational materials. Anyone reproducing or distributing these documents in a context other than private is subject to the penalties provided for by law.

### **Article 7: Possible disputes**

If a dispute or a dispute cannot be settled amicably, the dispute will be brought before the competent court of Nancy.
